Because the city streets are more narrow this year and have less room for vehicles to go around other vehicles while unloading, please drop off your booth supplies first, before you set up your booth, and then proceed to park. We apologize for any delays. Vehicles need to be out of faire area by 8:30 am or towed at owner's expense. Parking outside of faire only. Zone Managers (yellow vests) or Ambassadors (maroon vests) will assist you with directions or questions.

Your space will be reassigned to standby exhibitors if not occupied by 8:30 am.

"<u>Speedy" Renewal Process</u>: For those of you who would like to receive priority in renewing your same booth for the next Grand Avenue Festival on October 16th, 2022, we offer you an opportunity to renew your booth space on our convenient website. <u>Effective October 8th, 2021</u>, you may renew on line at <u>www.kennedyfaires.com</u>/escondido.Go to the Escondido tab and click on the <u>Oct 2022 Grand Avenue Festival "Speedy" Renewal link</u>.

All vendors with sales **must** have a valid California Sellers Permit, and it must be available.

Electricity not available unless arranged prior. No generators without prior approval. Bring your power cords. Only a space is provided. Tables, chairs, canopies, etc., are vendor's responsibility. All craft spaces are <u>12' frontage x 10' deep unless you</u> agree to a smaller space. We cannot guarantee separation from similar products or competitors. Vendors are responsible to carry their own liability insurance that will indemnify the City of Escondido, Escondido Chamber and Kennedy Faires.

## Please do not walk on the plants or store merchandise in the street median where plants are growing.

**IMPORTANT:** No exhibitor or participant may "hawk" merchandise or services. You must operate <u>within</u> your booth space and only sell products or promote services listed on your application, unless prohibited by management. <u>No</u> excessive noise or infringement on faire visitors or other exhibitors. You cannot exhibit/sell services or products that are not on your application. You must leave your booth space completely clean. <u>See new booth format on map. Some sections of Grand Ave</u> have been suspended from use temporarily. Your booth location from previous events may change. Sorry for any inconvenience.

SALES OF ILLEGAL ITEMS, WEAPONS (including certain types of knives such as double edge, switch blade, throwing or butterfly knives), EXPLOSIVES (including fireworks, poppers, snap caps, and bomb bags), or Potato Guns are prohibited and having them, COULD RESULT IN FORFEITURE OF FEES AND DISMISSAL from the Festival. No tobacco, tobacco/drug paraphernalia or any item promotes the use of any Federally Controlled Substance including Marijuana". Sale of items not listed on Festival application or deemed harmful or inappropriate by Festival staff is also grounds for forfeiture of fees and dismissal from the event. All CBD vendors are responsible to comply with Federal, State and Municipal regulations. Kennedy Faires is not involved in gualifications or disqualifications of CBD products. NO FREE FOOD OR BEVERAGES ARE ALLOWED TO BE DISTRIBUTED UNLESS PRIOR APPROVED

No exhibitor tear-down prior to 5:00 pm. Selling stops at 5:00 pm. Vendors and vehicles must leave streets by 6:30 pm-strictly enforced.
