# STATE OF CALIFORNIA-HEALTH AND HUMAN SERVICES AGENCY CALIFORNIA DEPARTMENT OF HEALTH

NOTICE: The California Department of Public Health (CDPH) has defined "Mega" Events as large crowds greater than 10,000 attendees at an outdoor venue effective Sept 20, 2021. Mega Events have the following health recommendations: Source document "Beyond the Blueprint for Industry and Business Sectors"-effective Aug 18, 2021 by Tomas J. Aragon, MD., Dr.P.H. and Gov. Gavin Newsom

# NOTICE: The State of California requires us to disclose the following recommendations about "Mega" Events: >10,000 attendees outdoors

- Verification of fully vaccinated status or pre-entry negative test results is strongly <u>recommended</u> for all attendees. Attendees who do not verify vaccination status should be asked to wear face coverings.
- Attendees must follow CDPH Guidance for Face Coverings
  - Fully Vaccinated persons, face coverings not required except when attending outdoor events such as fairs and festivals.
  - Unvaccinated persons, face coverings are required outdoors anytime physical distancing cannot be maintained, including when attending crowded outdoor events.
- Masks will be available at the Info Booth, at State/Grand Ave.

- The State of California requires us to disclose that guests are aware that the State strongly recommends guests are fully vaccinated, or obtain a negative COVID 19 test prior to attending event, or wear a face covering.
- State encourages you to get vaccinated
- State encourages everyone to sign up for CA Notify
- State requires disclosure that there is a risk of attending large crowded events where the vaccine status of others in attendance may be unknown to the individuals.
- State requires disclosure that there is a risk of attending large crowded events for populations that may not currently be eligible for vaccination, or may be immunocompromised and whose vaccine protection may be incomplete.

#### **NOTICE:** Information recommended for our Vendor's Responsibilities:

- If you are sick, have a fever and not feeling well, please stay home
- Do not enter the event if you are not feeling well
- Please follow current CDPH Guidance for face coverings
- Wash your hands often with soap and water or with alcohol-based sanitizer. Provided sanitizer for customers
- You may use cashless means to sell products
- Be mindful of your booth being too crowded and queue up customers as necessary
- All vendors will be responsible to screen yourselves and your employees for wellness
- Food Vendors should insure customer lines are controlled

# IMPORTANT NOTICE REGARDING POLICE TRAFFIC STEEL BARRIERS. (Your booth space may have changed) Please read and comply

The Carlsbad Police Dept. has adopted a new way to secure participants and patrons within the Carlsbad Village Faire. One of those many ways that they are protecting the community is to use new specialized traffic barriers. The Carlsbad Police also requires an open space between the new steel barriers and the booth occupant. If you have received one of these notices, it means that your booth space may have changed from previous years so that we could allow the required space to be maintained between the steel barrier and the closest booth, per Police standards. We are sorry for any inconvenience this may have caused, however this is for public safety for all.

## **IMPORTANT NOTICE FOR FOOD VENDORS Please read and comply**

It is your responsibility as a food vendor to insure your booth spaces is kept clean during the Carlsbad Village Faire. If you have products that will spill onto the pavement, curb, sidewalk, brick pavers or any other surface on site, you MUST insure that to cover (protect) those surfaces to prevent staining of the surface. If your booth is left unclean, you will be financially responsible for the cleanup and you may not be renewed as a vendor for future events.
