# **Encinitas Spring Street Fair**

Sat/Sun April 26-27, 2025 9 AM - 5PM

### NOTE: YOU MUST SET UP AND TEAR DOWN BOOTHS EACH DAY-NO OVERNIGHT BOOTHS ALLOWED

Please follow the SET UP & BREAKDOWN SCHEDULE in this confirmation package. Use your designated freeway exit and go directly to your space. Staff will help you find your space.

Have this SPACE CONFIRMATION & ASSIGNMENT sheet available. Assignment is for the space only - <u>you must provide your own canopy</u> <u>and fixtures</u>. Space size is 12 wide x 10 deep.

At your assigned space, PARK ADJACENT TO YOUR SPACE - LEAVE CURB SIDE CLEAR FOR OTHERS TO PASS. Unload quickly so other vendors can get in and around you to set up, then exit to the West to find parking. Vehicles must be removed by 8:30 AM or towed at owner expense. Parking on periphery of fair, in legal spaces only.

SALES STOP PROMPTLY at 5 PM <u>daily</u>. At 5 PM vendor vehicles return to booth spaces to load and depart. Sheriff enforces the 5 PM stop sales time to ensure the public vacates the highway and to ensure we break down and leave by 6:30 PM. Thank you for your cooperation! <u>We cannot guarantee a separation from competitors</u> <u>or similar products among vendors. Thank you for your</u> <u>understanding.</u>

BREAK DOWN. As the fair is located on a State Highway (South Coast Hwy 101), it must be reopened to traffic quickly <u>each night.</u> It must be cleared of vendors by 6:30 PM <u>daily.</u> At 6:30 PM the street cleaners and work crew will begin final street clean-up. CLEAN-UP OF YOUR SPACE AND REMOVAL OF TRASH IS YOUR RESPONSIBILITY! Your application will be rejected for future events if your space is not left clean. Please work with us to leave your area as clean as you found it.

SALE OF ILLEGAL ITEMS, WEAPONS (including certain types of knives), EXPLOSIVES (including fireworks, poppers, snap caps, and bomb bags) are prohibitive. No tobacco, tobacco/drug paraphernalia or any item that promotes the use of any Federally Controlled Substance, including Marijuana. Violations WILL CONSTITUTE FORFEITURE OF FEES AND IMMEDIATE DISMISSAL. Sale of items not

listed on application or deemed harmful or inappropriate by staff is also grounds for forfeiture of fees and dismissal from the event. <u>Cannot guarantee separated booths from similar product types or</u> <u>services. Due to strong winds, you are required to use weights on your</u> <u>canopy legs.</u>

**\*\*SPEEDY RENEWALS** are now "On Line". "Speedy Renewals" may be completed as early as April 26, 2025 on line in order to retain your space for the next Encinitas event on Sun November 23, 2025. Go to <u>www.kennedyfaires.com to renew on line.</u> **\*\*To insure you** <u>retain your same space, you MUST complete the renewal and</u> <u>provide payment information by April 26th, 2025. Sorry no</u> <u>exceptions.</u>

<u>ATTENTION!</u> City of Encinitas enacted a ban on plastic bags and styrofoam. Please bring alternative bags, reusable bags, etc. Plastic bags, serveware and Styrofoam are <u>NOT</u> allowed. <u>Encinitas Municipal</u> <u>Code Sec 11.26</u>. You understand and agree to NOT use styrofoam or plastic bags or serveware while participating as a vendor in the City of Encinitas during the Encinitas Street Faires. You understand if you do not comply, you may be subject to fines and/or dismissal from the Street Fair. <u>All products containing any or all compounds, blend, extract, infuse, parts or otherwise of the Cannabis staive Linneaeus, Cannabis indica or Cannabis ruderalis are prohibited in the City of Encinitas. These products are subject to removal. <u>See flyer with</u> <u>confirmation docs</u></u>

ELECTRICITY. Not available unless by prior arrangement. If you use a generator, it MUST be a "Quiet-Type" generator that has very low decibel and fume levels. If we receive complaints from neighboring vendors about your generator, you are at risk of being asked to turn it off.



FIRE, HEALTH & SAFETY. County Health Department inspects all food vendors for compliance. Food vendors are responsible for their own food permits.

#### FREEWAY EXITS FROM INTERSTATE 5 (SEE MAP - LEFT OF PAGE)

**WEST SIDE (EVEN) SPACE NUMBERS** - TAKE ENCINITAS BOULEVARD EXIT, THEN GO WEST ON ENCINITAS BOULEVARD TO SOUTH COAST HWY 101, THEN SOUTH ON HWY 101 TO EVENT BARRICADES.

**EAST SIDE (ODD) SPACE NUMBERS** - TAKE BIRMINGHAM EXIT, THEN GO WEST ON BIRMINGHAM TO SAN ELIJO, THEN LEFT 2 BLOCKS TO CHESTERFIELD, THEN RIGHT TO SOUTH COAST HWY 101, THEN NORTH ON HWY 101 TO EVENT BARRICADES AT THE INTERSECTION OF HWY 101 AND "J" STREET.

**SET UP SCHEDULE:** PLEASE ENTER THE FAIR AREA IN THE DIRECTION OF NORMAL TRAFFIC FLOW AND ADHERE TO SCHEDULED SET UP TIMES. YOU MAY ENTER FROM HWY 101, AS WELL AS THE SIDE STREETS "D" THRU "I." YOUR SPACE NUMBER IS NOTED ON THE REVERSE OF THIS FORM. *PLEASE UNLOAD IMMEDIATELY ADJACENT TO YOUR SPACE AND LEAVE CURBSIDE FREE FOR TRAFFIC TO PASS*.
